Subject: Filling up of the post of Deputy Director General (DDG) in Bureau of Civil Aviation Security (BCAS) in Level 13A in the Pay Matrix on deputation basis.

iv. An attested Statement indicating the grading in the APAR during the last five years;

v. cadre clearance;

vi. clearance from vigilance and disciplinary angle; and

vii. statement giving details of major or minor penalties, if any, imposed on the officer during the last ten years.

ANNEXURE-I

Eligibility Criterion for the post of DDG, BCAS, New Delhi.

1. Name of Post: Deputy Director General, BCAS, New Delhi.

2. Scale of pay: Level 13A in the Pay Matrix.

3. Recruitment method: by deputation.

4. Eligibility: Officers of the Central Government/ All India Service (AIS):

(A) (i) holding analogous posts on regular basis in the parent cadre or department; or

(ii) with two years' service in the grade rendered after appointment thereto on a regular basis in Level 13 in the pay matrix or equivalent in the parent cadre or department; or

(iii) with six years' service in the grade rendered after appointment thereto on a regular basis in level 12 in the pay matrix or equivalent in the parent cadre or department;

and

(B) possessing the following educational qualifications and experience:

Essential:

(i) Bachelors' degree in any discipline from a recognised University or Institute; and

(ii) minimum five years' experience in formulation, appraisal, execution or implementation, research, monitoring and evaluation of policy, programme or projects.

Desirable:

Two years' experience of work in -

(i) an economic or infrastructure related matters;

(ii) International co-operation; or

(iii) security or aviation security.

5. Period of Deputation: Period of deputation including period of deputation in another, ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed five years.

6. Age Limit: The maximum age limit for appointment by deputation shall not be exceeding fifty-six years as on the closing date of the receipt of applications.

7. The applicants may send their application for the post of DDG in BCAS within six weeks of the publication of the advertisement for the post in employment News.

Note – i) Candidates will be allowed to submit the NOC/Cadre Clearance from parent department to this Ministry in case of their selection by Screening Committee at the post of DDG, BCAS. However, it is desirable that NOC/Cadre Clearance be sent to this Ministry beforehand for consideration of any application.

ii) Candidates who have submitted their applications for the post of DDG, BCAS that had been invited vide this Ministry's OM dated 11.08.2025 may only forward their application as per attached proforma for preventing any duplicity of redundant documents. However, a copy of latest Vigilance Clearance is mandatory.
