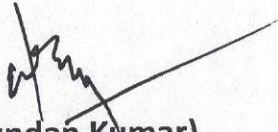

04 01.07.2026	Advocate Mr. Gyan Shankar, Ld. Counsel for BIADA and Advocate Mrs. Shraddha Roy, Ld. Counsel for the Appellant are present. Ld. Counsel for the appellant submitted that Shri Sanjeev Kumar, proprietor of M/s S & R Company, was allotted Plot No. A-10 (P-II), measuring 3390 sq. ft., in Industrial Area Muzaffarpur vide Letter No. 3449/D dated 12.06.2024 for establishment of an industry relating to Gate, Grills, Windows & Doors and physical possession of the allotted plot was handed over to the unit on 23.07.2024. Thereafter, vide Letter No. 5446/D dated 14.11.2024, in place of Plot No. A-10 (P-II), Plot No. A-38 (P-I), measuring 3283 sq. ft., situated in Industrial Area Muzaffarpur, was allotted to the unit and physical possession of Plot No. A-38 (P-I), measuring 3283 sq. ft., was handed over to the unit on 29.11.2024. The allotment of land in favour of M/s S & R Company was cancelled vide Memo No. 162 dated 19.02.2026. Thereafter, unit submitted an application on 30.03.2026 seeking revival under Amnesty Policy, 2025. Thereafter, vide Letter No. 307 dated 06.04.2026 and Letter No. 398 dated 06.05.2026, the unit was directed to deposit outstanding dues amounting to Rs. 3,85,906/- towards payment of dues under Amnesty Policy, 2025. Appellant has been granted in-principle approval under the Amnesty Policy, 2025 vide Letter No. 494 dated 01.06.2026. Therefore, requested to withdraw the instant appeal for availing the benefit of Amnesty Policy, 2025. Appeal is allowed to be withdrawn.
