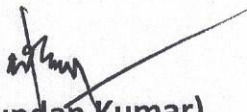

| 02<br>08.07.2026             | <p>Appellant in person and Representative of BIADA are present. Representative of BIADA submitted reply and stated that there is outstanding dues of Rs. 34,27,691/-. Appellant was already granted three months' time by the MD, BIADA vide order dated 05.11.2025 to pay the dues of BIADA. DGM-ID, Darbhanga Cluster has cancelled the allotment of unit on 18.03.2026 as unit is not clearing the dues.</p> <p>Mr. Pravir Kumar Pankaj, representative of the appellant stated that three months' time is required to pay the outstanding dues.</p> <p>Representative of BIADA stated that already ample opportunity has been given to the appellant but he has failed to pay the outstanding dues.</p> <p>Considering the submissions of both sides, a last opportunity is granted to the appellant to clear the dues in next three months in three equal installment which shall be paid by the end of every month.
