Tender Notice

Sealed tender under TWO BID SYSTEM is hereby invited by the Govt. of Bihar for Purchase of Cockpit Voice Recorder (CVR) Part no. 2100-1020-00 for King Air C-90 A/B VT- EBG Aircraft as per the following terms and conditions:

1. Bid submission starts from **22.07.2026** Tender Schedule has been provided in Sl. No 9 of this Notice.
2. The tender must reach to Secretary, Civil Aviation Department, Patna, Airport on or before **12.08.2026 at 05:00 PM.** by registered post/speed post/courier or by hand only.
3. Bidders shall submit their offer in **two separate sealed envelopes** one as Technical Bid and other as Financial Bid. The type of Bid must be written on each envelope (Technical/ Financial Bid). These two bids shall be kept in another big envelope which should be sealed and subscribed as "**Tender for Purchase of Spares for King Air C-90 A/B, VT- EBG Aircraft.**"
4. **Technical Bid should contain the following:**
 - A. An undertaking in the form of affidavit on 100 Rupees stamp paper that the Company has not been blacklisted by any Public Sector undertaking/ Government Organization/ DGCA.
 - B. An EMD of Rs 50,000.00 (Rs fifty thousand only) in the form of Bank Draft issued by a Scheduled/ Nationalized Bank in India, drawn in favour of Civil Aviation Department, Bihar.
 - C. Self-attested copies of GST registration and PAN details.
 - D. Income Tax return certificate for Preceding three Assessment years (2023-24, 2024-25 & 2025-26) of the bidder.
5. **Financial Bid should contain the following:**
 - A. The quoted rate shall be for door delivery to the **Civil Aviation Department, State Hangar, Patna, Bihar**, inclusive of all taxes, with no additional charges applicable or payable.
 - B. Rate should be quoted in Indian Rupees (₹) only.
 - C. Financial bid shall clearly specify delivery schedule and payment terms.
 - D. Financial bid shall specify the validity of quoted rates for a period of 120 days from the last date fixed for submission of tenders.
6. Evaluation of financial bid will be done on the basis of the quoted rate. Financial bid will be opened only of those bidders whose technical bid are found to be responsive and meet all specified requirements.
7. Security money of Unsuccessful bidders will be refunded immediately after final selection.
8. The Technical & Financial bid of the tender will be opened tentatively on **13.08.2026 at 03:00 PM** before the committee headed by Secretary, Civil Aviation Department, Bihar, Patna or by an officer so authorized by him before bidders/ authorized representatives.

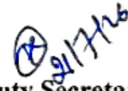

The successful bidder shall furnish Performance Guarantee after getting Letter of Intent, in the form of Bank Draft or Bank Guarantee issued by Scheduled/ Nationalized Bank in India for a sum equivalent to 5% of the total tender value in the favour of Civil Aviation Department, Government of Bihar
11. Any queries and questions regarding the tender should be addressed to Accountable manager, Civil Aviation Department, Patna (either through letter or through e-mail: - cadbihar@bihar.gov.in or contact no. 9905035154) up to 7 days before the last date fixed for submission of tenders.
12. If the Company/Contractor/Individual fails to supply the spare within the specified delivery timeline, a penalty at the rate of 2% of the total cost of the spare shall be deducted from the tax invoice for every week delay subject to maximum deduction of 10%.
13. In case of any dispute, the place of settlement will be within the Judicature of High Court at Patna.
14. The Secretary, Civil Aviation Department, Bihar reserves the right to reject/ cancel any/ all tenders without assigning any reason thereof.
