**SHORT TIME NOTICE FOR QUOTATION INVITATION FOR FLOOD AMBULANCE**

Office inviting quotation: - Executive Engineer, Western Embankment Division, Nirmali, Supaul.

Sealed Quotation is invited from the service provider for the procurement of working and well maintained 1(one) no Flood Ambulance with 06 Nos labors, Generator mounted on Camper with sufficient lighting arrangement on hire basis for the period from 01 July-2026 to 31 Oct-2026 to be Deployed on WESTERN KOSI EMBANKMENT (Km 27.00 TO 54.09). As per requirement the machine may be moved/deployed at any vulnerable point under the Jurisdiction of this Division. The Flood Ambulance will be used in flood fighting work at site in night whenever & wherever there is urgency. Therefore, the service provider or representative will have to be present at site.

**1. Specification of Flood Ambulance**

- (i) Labour-06 Nos.
- (ii) Camper.
- (iii) Generator 5KVA mounted on Camper. Flood light 50watt 3 Nos [2 Nos Fixed with Camper & 1 No Movable up to 25M]
- (iv) Generator Operator 01 No.
- (v) Camper Driver 01 No.
- (vi) Service provider should quote the rate for following two conditions for one machine.

(a) In Idle condition Rate- (A) ₹.....per hour.

(b) During working period Rate- (B) ₹.....per hour.

(Rate should be inclusive of machine operator, Khalasi, Fuel and all other types of P.O.L required for the working of machine, etc. charges & including all taxes).

**2. Evaluation of the quotation will be done on the basis of the following formula-**

Evaluation Cost per hour =  $A \times 0.3 + B \times 0.7$

Where A = Rate during Idle period

B = Rate during working period.

**Work will be allotted to the service provider whose evaluation cost will be lowest, subjected to final approval of competent authority.**

**3. Conditions: -**

- (i) Sealed quotation is being hereby invited by agencies which will apply for nomination under C.E, Flood Control & Drainage, WRD, Birpur.
- (ii) Service Providers should be registered firm in WRD and should have valid G.S.T registration, character and PAN Card. Attested copy will have to be submitted at the time of filling nomination.
- (iii) Income Tax, service Tax etc. as applicable will be deducted from the bill of service provider as per Norms.
- (iv) Maintenance and security of machine will be done by service provider.
- (v) In case of breakdown of machine, two times the rate of Idle period will be deducted from the bill.
- (vi) Attested Copies of all essential documents related to Flood Ambulance will have to be submitted at the time of Deployment.
- (vii) In Case Camper/Generator is taken on lease by the service provider, the affidavit for the same of lender's must be attached in original with the quotation.

- (viii) Payment will be done on the basis of approved nomination as well as Format-24 and as per availability of allotment. No Claim whatsoever will be entertained for this.
- (ix) Flood ambulance will have to be made available in ready to working condition with P.O.L. & all required staff etc.
- (x) All Valid documents including fitness certificate would be submitted with quotation.
- (xi) All the payment of the machine will be done on the basis of entry in Log book and a daily communication to the department for final approval.
- (xii) Maximum Age of Flood Ambulance should not be more than 8 years.
- (xiii) Maximum Idle Working hours will be 12 hrs/day.

Sealed Quotation and accompanying document must be submitted on or before 15.06.2026 up to 3:00 PM at office of the Executive Engineer, Western Embankment Division, Nirmali, Supaul./Superintending Engineer, Eastern Koshi Embankment Circle, Saharsa and Chief Engineer, Flood Control and Drainage, Water Resources Department, Birpur. All quotation will be opened on same day i.e 15.06.2026 at 4:30 PM at the respective offices.
