



04 20.05.2026	<p>Appellant in person and Ld. Counsel for BIADA are present.</p> <p>Ld. Counsel for BIADA stated that report from DGM, ID, Darbhanga has received and brought on record. He further stated that part cancellation of 750 Sq. Ft. land was made against which they have filed SLP in Hon'ble Supreme Court which is under defect and they will withdraw the same. He further stated that this land is a locked land surrounded by 0.025 Acre land on which appellant is still working but the lease of that land has expired. He has submitted application for extension of lease period as per BIADA norms.</p> <p>Appellant stated that on another 300 Sq. Ft. third party right has been created, they have no objection. Appellant further stated that they want to revive the 750 Sq.
