





11 27.05.2026	<p style="text-align: center;"><b>Shri Om Prakash Upadhyay, representative of the appellant and Ld. Counsel for BIADA are present.</b></p> <p>Ld. Counsel for BIADA stated that earlier Shri Upadhyay was running a unit in the name of Prakash Ranjan Zarda Factory which was cancelled on 01.08.2007. Thereafter, the plot in question was allotted to M/s Kisan Flour Mill for production of Atta, Sattu &amp; Besan in which Shri Upadhyay has 10% stake in the unit and 90% stake with one Deepak Kumar. M/s Kisan Flour Mill was cancelled on 23.07.2022, and restored in Appeal No.146/2022 on 23.12.2022. Thereafter, upon inspection the unit was found non-functional. Shri Upadhyay has filed this Appeal against the Letter No. 68 dated 28.03.2023 whereby his application was rejected for addition of product, and change of name of Unit from Prakash Zarda to Prakash Namkin and to continue the work on 1500 Sq. Ft. by separating the same from 5000 Sq. Ft land.</p> <p>Shri Upadhyay stated that the land was originally allotted for production of zarda in the name of Prakash Ranjan Zarda Factory in 30.07.1987 which was cancelled arbitrarily and allotted to Kisan Flour Mill in which he has 10% shareholding and his partner Deepak Kumar has 90% share is not doing work since long but now he wants to continue the work of Namkin if 1500 Sq. Ft. land is allotted in his</p>	



name by separating the same from the total 5000 Sq. Ft. land.

Heard rival submissions. As it is clear that Shri Upadhyay is having 10% shareholding in Kisan Flour Mill and has filed the present appeal but his other partner has never come to clear the position. Even the Unit is functional minimally and wants to separate the land from original allotted land which is not viable. Hence this appeal is dismissed.
