File No. 18/Vividh-18/2017 -572(18) In exercise of the powers conferred by Section 54 of the Clinical Establishments (Registration and Regulation) Act, 2010, the Governor of Bihar hereby makes the following Rules to amend the Bihar State Clinical Establishments (Registration and Regulation) Rules, 2013:-

1. Short title, extent, and commencement. —

- (i) These Rules may be called the “Bihar State Clinical Establishments (Registration and Regulation) (Amendment) Rules, 2026.”
- (ii) It shall extend to the whole of the State of Bihar.
- (iii) It shall come into force on the date of their publication in the Bihar Gazette.

2. Rule-1(2) of the Bihar State Clinical Establishments (Registration and Regulation) Rules, 2013, read with Rule-2 of the Bihar Clinical Establishments (Registration and Regulation) (Amendment) Rules, 2025 is hereby substituted by the following:

"Rule-1(2)-It shall extend to the whole of the State of Bihar and shall apply to all clinical establishments in the State having more than 40 beds."

3. Insertion of Sub-rule- (4) in Rule-1 of the Bihar State Clinical Establishments (Registration and Regulation) Rules, 2013:

"Rule-1(4)-Clinical establishments other than as mentioned in above Rule 1(2) may have option to get themselves registered under the “Bihar State Clinical Establishments (Registration and Regulation) Rules, 2013” and such clinical establishments shall not be required to obtain registration under any other rule/regulation promulgated by the State Government."

4. Rule-20(1) of the Bihar State Clinical Establishments (Registration and Regulation) Rules, 2013 shall be substituted as under:-

"Rule-20(1)- The applicant shall apply to the District Registration Authority for provisional registration as well as related departmental approval through the centralised digital portal of the Single Nodal Agency(SNA) with the necessary information in the format as per the SG AR Annexure under Section 14(1) and 14(3) of the Act.

5 **Rule-20(2) of the Bihar State Clinical Establishments (Registration and Regulation) Rules, 2013 shall be substituted as under:-**

"Rule-20(2)- The applicant shall apply to the District Registration Authority for permanent registration as well as related departmental approval through the centralised digital portal of the Single Nodal Agency(SNA) with the necessary information filled and with evidence of having met the requirements of minimum standards and personnel for different categories of Clinical Establishments in a form and format that shall be prescribed by the National council under Section 14(1) and Section 30 of the Act. However, if a laboratory or diagnostic center is part of an establishment providing outpatient/ inpatient care, no separate registration will be required.

6. **Rule-23(1) of the Bihar State Clinical Establishments (Registration and Regulation) Rules, 2013 shall be substituted as under:-**

"Rule-23(1) The district Registration Authority shall grant a certificate of permanent registration As per format developed by National council through above mentioned centralised digital portal of the Single Nodal Agency after satisfying itself that the applicant has complied with all the requirements and criteria, including provision of minimum standards and personnel required to run the clinical establishment."


7. **Insertion of Sub-rule-(10) in Rule-24 of the Bihar State Clinical Establishments (Registration and Regulation) Rules, 2013:**

"Rule-24(10) The Clinical Establishments shall pay the Processing fee in addition to the registration fee to the Single Nodal Agency as determined by the State Government from time to time."

8. **Insertion of Sub-rule-(7) in Rule-27 of the Bihar State Clinical Establishments (Registration and Regulation) Rules, 2013:**

"Rule-27(7) The Single Nodal Agency shall compile all deficiencies/ defects pointed out by various departments (like Fire, Pollution, Drugs etc.) for setting up Clinical Establishments and a consolidated memorandum will be issued by said agency to the applicant for rectification of the said deficiencies/defects within the statutory time period."
