

**GOVERNMENT OF BIHAR

NOTIFICATION

The state Government enacted the **Bihar Industrial Investment Promotion Act, 2016 (Act 19 of 2016)**, enforced vide notification no: 4192 dt. 06.09.2016, Department of Industries, Government of Bihar, to facilitate the promotion and development of investment within the State of Bihar. The primary mandate of the Act is to simplify administrative procedures for the establishment and operation of industries, thereby establishing the State as a premier destination for domestic and international investment. While the implementation of the digital framework has successfully transitioned the front-end of the single-window clearance system to an online interface, the underlying backend processing remains fragmented across individual line departments. This sequential, multi-agency regulatory structure inherently introduces administrative complexity, increases transaction costs, and impedes the timely implementation of projects.

2. Hence, for the authorization of the Secretariat of the State Investment Promotion Board (SIPB) as the Single Nodal Agency for all pre-establishment, construction, connection, and operation stage approvals under Section 10 of the Bihar Industrial Investment Promotion Act, 2016, the following propositions has been approved:

A: Authorization of the Secretariat of the SIPB as the Single Nodal Agency

Under Section 10 of the Bihar Industrial Investment Promotion Act, 2016. This notification shall authorize the Secretariat of the State Investment Promotion Board (SIPB) to function as the Single Nodal Agency. In this capacity, the Secretariat shall be vested with the definitive power to grant and issue all required clearances mandated for industries in the State of Bihar.

B. Deputation under the Secretariat of the State Investment Promotion Board (SIPB)

The officers, as mentioned in Section 6 (2) (a to h) of the BIIP Act, 2016, are hereby deputed to function under the direct administrative command, disciplinary control, and supervision of the Industrial Development Commissioner (IDC), as defined under Section 6(1) of the BIIP Act, 2016, for the issuance of clearances. This deputation is aimed at achieving convergence of all concerned departments within a single administrative command to facilitate expedited clearances.

C: Delegation of Authority for including Officers in the SIPB:

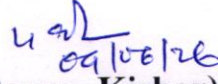
Drawing powers from Section 10 of the Bihar Industrial Investment Promotion Act, 2016, the Industrial Development Commissioner (IDC) is hereby authorised by the State Government to issue formal orders regarding deputation to include competent nodal officers of the State Departments and statutory bodies as per requirement in the Secretariat for issuance of clearances. The exercise of this administrative power shall be initiated upon consultation with the concerned department or entity, and any such structural modification or requisition of personnel shall be subject to the final approval of the State Investment Promotion Board (SIPB).

D. Determination of Standard Operating Procedures

The State Investment Promotion Board is hereby authorized to formulate and notify comprehensive Standard Operating Procedures for procedural workflows under this centralized framework.

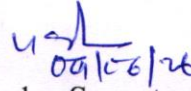

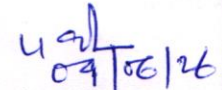
