

No-.....184(17)..... In exercise of powers conferred under proviso to
Article 309 of the constitution of India, the Government of Bihar is pleased to make
following Rules to amend the “Senior Resident/Tutor and Bihar Medical Education
Service Recruitment, Appointment and Promotion Rules, 2008 (as amended from time
to time) under the Health Department :-

- 1. Short title, extent & commencement:** - (i) These Rules May be called as
the “Senior Resident/Tutor and Bihar Medical Education Service Recruitment,
Appointment and Promotion (Amendment) Rules, 2026”
(ii) It shall extend to the whole State of Bihar.
(iii) These rules shall come into effect from 03.04.2025, and shall also apply
to those cases in which the department has sent a requisition for selection to
the Commission, but the merit list has not been published. These rules will be
published in the Official Gazette.

2. **The Substitution of rule-7 of the Senior Resident/Tutor and Bihar Medical Education Service Recruitment, Appointment and Promotion Rules, 2008 (as amended from time to time):-** The Rule -7(iii)(a) of the said Rules is hereby substituted by the following:-

“ For appointment to the post of Assistant Professor, it shall be essential for the candidates to have post-graduation degree in specified subject and thereafter one year teaching experience as Senior Resident or Tutor, in hospitals recognized by the Medical Council of India at Present National Medical Commission. Such officers of the Bihar Health Service Cadre, who have post-graduation degree in the concerned subject and minimum one year teaching experience as Resident/Senior Resident/Tutor in Hospitals recognized by the Medical Council of India at Present National Medical Commission, shall also be eligible to apply for the post of Assistant Professor.”

3. **The Deletion of Annexure-A (2) and Annexure-B(4) of the Senior Resident/Tutor and Bihar Medical Education Service Recruitment, Appointment and Promotion Rules, 2008 (as amended from time to time)** :- The Annexure-A(2) and Annexure-B(4) of the said Rules shall be deleted.

4. **The Substitution of Annexure-B (2) of the Senior Resident/Tutor and Bihar Medical Education Service Recruitment, Appointment and Promotion Rules, 2008 (as amended from time to time) :-** The Annexure-B(2) of the said Rules is hereby substituted by the following:-

Such officers of the Bihar Health Service Cadre, who have post-graduation degree and thereafter minimum one year teaching experience as Resident/Senior Resident/Tutor in hospitals recognized by the Medical Council of India at Present National Medical Commission, shall be eligible to apply for the post of Assistant Professor.

5. **The Addition in Annexure-B (3) Second (d) of the Senior Resident/Tutor and Bihar Medical Education Service Recruitment, Appointment and Promotion Rules, 2008 (as amended from time to time) :-** In the Annexure-B(3) at the end of Second (d) of the said Rules following shall be added:-

“The work experience in equivalent positions in all government/non-Private (Including Institutions run by Central Government, Panchayat, Municipal bodies etc.) medical educational institutions operating within the State of Bihar shall be considered as valid work experience.”


