

Request for expression of interest for concurrent auditor

(A) Brief Profile

The state government has established Bihar Samvad Samiti, a registered society under the provision of Society Registration Act 1860, to know, understand the mood, perception, feedback of citizens on various issues, to receive their reaction and response, development of creatives for giving wide publicity to policy/programs/achievements of government to educate and sensitize people by establishing effective communication and for the development of "Brand Bihar", for the documentation of the development and achievements, to advertise, to facilitate the advertising material and place the Government views on suitable platforms as per requirement.

EOI is invited from interested CA firms to carry out concurrent audit of Bihar Samvad Samiti for the year 2024-25, 2025-26 and 2026-27. Scope of Work, Eligibility criteria and submission & evaluation details are as follows-

(B) Scope of Works:-

1. Firm would carry out concurrent audit through an Auditor as per the provisions of Bihar Samvad Samiti's Financial and Procurement Manuals, Since the preparation of Samiti's Financial and Procurement Manuals is in process and it is likely to take some time to be finalized, till then the audit would be done in accordance with provision of Bihar Financial Rules.
2. Audit would cover entire Samiti's operation.
3. The concurrent audit will be done by the Chartered Accountant firm through its authorized representative deputed by the selected firm.
4. Authorized representative so deputed by the CA firm will be semi qualified having minimum educational qualification of Inter CA with one year experience.
5. The authorized representative will have to be available at Samiti office during office hour on all working days.
6. CA firm while submitting monthly bill will also submit certified attendance of the representative.
7. Representative of CA firm deputed at office of the samiti, will not be replaced without prior consent of the Samiti.
8. The Auditor should have the knowledge of Bihar Financial Rules, Corporate Law.
9. The term of the contract may be extended, in case the services of the firm are found to be satisfactory.
10. In case, the services of the representative of CA firm is found unsatisfactory by the management of Bihar Samvad Samiti, the CA firm shall replace him/her withing seven days of receiving such request from Bihar Samvad Samiti.
11. At the end of each month, selected CA firm will submit a monthly report incorporating its observation/irregularities found and corrected.

(C) Eligibility Criteria:-

1. The CA should be empanelled with CAG (copy of empanelment should be attached)
2. Firm should be registered with ICAI with minimum 5 year of existence (Copy of registration should be attached)
3. Firm should have income tax, pan number and GST registration number. (Copy of registration should be attached)

4. The CA firm should have minimum 3 years of experience of auditing Government Departments/Government Board/Government Corporation/Government Society. (Copy of registration should be attached)

5. The Firm should have never been indicated by the court of law or any other regulatory authority or any states/Central Government and must not have been black listed earlier (A declaration should be attached)

(D) General:-

1. The selected firm will not sublet the assignment to any other CA firm/s or individual chartered accountant. If such practice is found the society will be at liberty to remove the assigned or individual and blacklist the firm.

2. The selected firm is expected to abide by the conditions mentioned in the EOI or else Samiti will have right to cancel the agreement and the firm will be liable for blacklisting also.

3. The technical committee of the society will scrutinized the applications and firm will be selected on the basis of fulfillment of the minimum eligibility criteria.

4. The samiti will have the right to cancel any application and/or postpone the process of selection at any stage without assigning any reason there of.

5. The application must contain a bank draft of Rs. 10,000/- (Ten Thousand) as EMD. EMD of unsuccessful bidder will be returned after the entire bidding process.

6. The successful bidder has to submit 5% performance security in the form of Bank Gaurantee.

7. The technical bid, containing all the supporting documents for the eligibility criteria, should be enclosed in a separate sealed envelope sub scribing "**Technical Bid for Concurrent Audit**" consisting-

i. Self attested copy of certificate of empanelment with CAG.

ii. Self attested copy of certificate of registration with ICAI with minimum 5 years of experience.

iii. Self attested copy of income tax, PAN and GST registration number.

iv. Self attested copy of certificate or documentary proof of minimum 3 years of experience of auditing of Government Department/Government Corporation/Government Society.

v. A declaration of not having been convicted by the court of law or any other regulatory authority or any state/central government and not having been blacklisted earlier.

vi. Duly filled application form in prescribed format alongwith a bank draft of Rs. 10,000/- (Ten Thousand) as EMD in favour of Bihar Samvad Samiti payable at Patna.

8. The financial bid, containing a single consolidated quote of monthly fees inclusive of all taxes and expenses should be enclosed in a separate sealed envelope sub scribing "**Financial Bid For Concurrent Audit**".




