Sl. No.	Queries & Suggestions by interested Bidders	Department's Reply
1	Request to increase contract period to 6+4 years or 7+3 years for sustainability.	The contract duration shall remain as per RFP. However, the contract may be extended based on satisfactory performance and requirement of the department.
2	Request to consider only Government Department experience instead of PSU experience.	Work orders issued by Government Departments as well as Public Sector Units (PSUs) will also be considered.
3	Request to reduce experience criteria from 500 licenses to 75 Government licenses or 50 projects.	The eligibility criteria shall remain as specified in the RFP considering the scale of implementation.
4	Request to increase minimum turnover requirement from ₹ 3 Crore to ₹ 10 Crore.	The turnover criteria shall remain as mentioned in the RFP document.
5	Request to reduce Performance Bank Guarantee (PBG) to 2%.	Performance Bank Guarantee shall be 5% of the contract value.
6	Request for 10% annual escalation during contract extension.	No escalation shall be applicable. Terms shall remain as per RFP.
7	Request to include condition of minimum 50 EPF/ESIC registered employees.	The eligibility conditions shall remain as defined in the RFP.
8	Request for milestone-based payment structure such as 40%-30%-30%.	Payment terms shall remain as specified in the RFP document.
