Eligibility Criteria

- 1) The candidate should not be more than fifty-eight years of age as on the closing date of receipt of application.
- 2) Up-to-date Annual Confidential Reports Dossiers for the last five years as applicable shall be available.
- 3) No Vigilance or Disciplinary case should be pending or contemplated against the candidate.
- 4) The qualifications and experience for the posts of Member (Irrigation) & Member (Power) are as under: -

Member (Irrigation) . - The candidate should be an engineering graduate in Civil or Mechanical Engineering from a recognised University or Institution; and

(A) the candidate should possess twenty years of regular experience with a minimum of one year experience (as on the closing date of receipt of application) as, -

- (i) Chief Engineer or equivalent in level-14 in the pay matrix (Rs. 144200-218200) or higher post under the Central Government; or
- (ii) Chief Engineer or equivalent or higher post under the State Government or State Public Sector Undertaking; or
- (iii) such post carrying the pay scale of Rs.150000-300000 (Industrial Dearness Allowance) or equivalent or higher pay scale in the Central Public Sector Undertaking, and

(B) the candidate should possess at least five years of work experience during the last ten years in planning or design or construction or operation and maintenance of major irrigation system.

Note: Preference shall be given to candidates having such experience of working in Department or Undertaking of the State Government of Haryana.

Member (Power) . - The candidate should be an engineering graduate in Electrical or Mechanical Engineering from a recognised University or Institution; and

(A) the candidate should possess twenty years of regular experience with a minimum of one year experience (as on the closing date of receipt of application) as, -

- (i) Chief Engineer or equivalent in level-14 in the pay matrix (Rs. 144200-218200) or higher post under the Central Government; or
- (ii) Chief Engineer or equivalent or higher post under the State Government or State Public Sector Undertaking; or
- (iii) Such post carrying the pay scale of Rs.150000-300000 (Industrial Dearness Allowance) or equivalent or higher pay scale in the Central Public Sector Undertaking, and

(B) the candidate should possess at least five years of work experience during the last ten years in planning or design or construction or operation and maintenance of,-

- (i) power plants; or
- (ii) transmission lines (minimum voltage level 66 kilovolts or above).

Note: Preference shall be given to candidates having such experience of working in Department or Undertaking of the State Government of Punjab.

PROFILE OF BBMB

The Bhakra Management Board (BMB) was set up by the Ministry of Power in terms of the provisions of the Punjab Reorganization Act, 1966 for the administration, maintenance and operation of the Bhakra Nangal project, a joint venture of the States of Rajasthan and the successor states of the erstwhile state of Punjab.

Beas Construction Board (BCB) was constituted under the Act for the construction of Beas Project and on completion of Beas Project Works, it was transferred to Bhakra Management Board (BMB) as per the provisions of Section 80 of the Punjab Reorganization Act, 1966. Pursuant to this Bhakra Management Board was renamed as Bhakra Beas Management Board (BBMB) w.e.f. 15th May 1976. BBMB is, therefore, looking after the administration, maintenance and operation of the Bhakra Nangal and Beas Projects, which are joint ventures of the State Governments of Punjab, Haryana, Rajasthan and Himachal Pradesh.

JOB DESCRIPTION

The post of Member (Irrigation) & Member (Power), BBMB carries with it a great deal of responsibility as there are a number of intricate Inter-State problems of the participating State Governments of Punjab, Haryana, Rajasthan and Himachal Pradesh which calls tact and mature judgement.

Member (Irrigation) acts as advisor to the Chairman, BBMB for technical matters relating to the existing irrigation projects of Bhakra Dam Complex, Beas Dam Talwara, Beas-Satluj Link Project, Nangal Dam & Nangal Hydel Channel and other matters as the Chairman, BBMB may deem fit.

Member (Power) acts as advisor to the Chairman, BBMB for technical matters relating to existing Power Projects, Transmission Systems, System Operation and other matters as the Chairman, BBMB may deem fit.

PAY SCALE

(i) The posts of Whole Time Members i.e. Member (Irrigation) and Member (Power) in BBMB carries a pay as per level-15 in the pay matrix (Rs. 182200-224100), in accordance with the provisions of the Central Civil Services (Revised Pay) Rules, 2016:

Provided that where a person serving under the State Government or the Central Government or the Public Sector Undertaking is appointed as Whole Time Member, such appointment shall not adversely affect the pay, increment, gratuity, pension or other retirement benefits which he would have drawn or received as if he had not been so appointed as Whole- Time Member in BBMB.

(ii) A whole-time Member shall be entitled to such travelling allowance and other allowances as are admissible to the officers of the highest grade of the Government of Punjab under the Punjab Civil Services Rules, Vol. III (Travelling Allowance Rules) as referred to in rule 6, or as admissible to the Chairman-cum-Managing Director or Directors of the other Central Public Sector Enterprises (Hydro Power) of the

Government of India or as adopted from time to time, by the Bhakra Beas Management Board for its highest ranking officers, with the approval of the Central Government, whichever is higher:

Provided that in case of a person serving under any Central Public Sector Enterprise coming on deputation to the Bhakra Beas Management Board, the performance related pay shall not be admissible during their deputation in the said Board.

(iii) The salary and allowances of the Whole-time Members shall be paid out of the funds of the Board.

Term of office of whole -time Members

Terms of office of the Whole Time Members in BBMB is guided by the provisions of Rule 3 of the Bhakra Beas Management Board Rules, 1974 which is stated as under:-

(1) Notwithstanding the terms and conditions of service obtaining in his/her parent department and superannuation from his/her parent department, the whole-time Member shall continue to hold office for a term of three years from the date on which he/she assumes charge of his/her office:

Provided that the whole-time Member shall, notwithstanding the expiration of his term of office, continue to hold office until his successor is appointed.

Provided further, that the whole-time Member shall not hold office beyond the age of Sixty years:

Provided further that, the whole-time Member shall be eligible for re-appointment for a further term of three years:

Provided also that total tenure including the extended period and intervening period between first and second appointment, if any, on the post of whole-time Member, Bhakra Beas Management Board shall not exceed six years.

(2) The whole-time Member may resign his office by writing under his hand addressed to the Central Government after giving notice of at least three months:

Provided that the whole-time Member shall cease to be in office from the date following the expiry of the period of notice given by him to the Central Government.

(3) The Central Government, for reasons to be recorded in writing, may, if it is of opinion that it is necessary or expedient so to do, terminate the term of office of the whole-time Member by giving a notice in writing of not less than ninety days or in lieu of such notice, on payment to such whole-time Member, an amount equal to the amount of pay and allowances which he would have drawn for the said period of ninety days:

Provided that if such whole-time Member is on deputation from any State Government, State Electricity Board, Central Public Sector Undertaking or the Central Government, the Central Government may at any time by order return his services to such Government or Electricity Board, or Central Public Sector Undertaking.
