

<p>28 22.04.2026</p>	<p>Ld. Counsel for the appellant and BIADA are present.</p> <p>Ld. Counsel for the appellant stated that he has applied for trade mark on 14.05.2024 and on 13.04.2026 a meeting was convened with officials of trade mark through video conferencing and it is under process of final stage and sought adjournment for one month and requested that after getting the trade mark, unit shall be made functional. He further said that he has invested approx. Rs.1.5 Cr..</p> <p>Ld. Counsel for BIADA stated that it is a fit case for dismissal because unit was never functional and premises is just using as godown. Even premises was rented for light and crockery storage. During inspections, it revealed that unit was found closed. Possession is with BIADA. So far getting trade mark is concerned it was applied on 14th May, 2024 but after lapse of approx. two years they are again taking same plea of getting trade mark which is not a ground for revival.</p> <p>Heard rival submissions of both the parties, Since, land was allotted in the year 2009 and first time it was cancelled on the ground of non-functional and restored in 2015, again in 2024 it was cancelled.
