**Short term emergent Notice of Quotation invitation for Tyre Mounted Hydraulic
Excavator(J.C.B.)**

Sealed quotation is invited from the service provider for the procurement or working and well maintained Tyre mounted hydraulic excavator on hire charge basis for the period Flood 2026 on G.H. Portion between KM. 0.00 to 6.62 Where ever and when ever required under divisional jurisdiction of Padrauna on river Gandak in District West Champaran. The tyre mounted hydraulic excavator will be used in flood fighting at G.H. Embankment on the right side of river Gandak during day or night whenever & wherever required in urgency. Where as the tyre mounted hydraulic excavator will be used in Jungle clearance, loading unloading of filled sand bags, loading & unloading of soil, shoal cutting in Gandak river etc. Therefore, the service provider will have to be ready all the time at site with machine, operator, khalasi & fuel etc.

1. Specification of Tyre mounted Hydraulic Excavator

- (i) Boom length (including arm length) -(Minimum 5.4 M to 6 M)
- (ii) Bucket capacity -0.26 M³ to 0.3 M³
- (iii) Shovel Capacity - 1.1 M³ to 1.2 M³
- (iv) Service provider should quote the rate for following two conditions:

(a) In Idle conditions Rate Rs.....Per Hour. (Rate should be inclusive of operator, khalasi etc charges)

(b) During working period rate Rs..... Per Hour. (Rate should be inclusive of fuel, mobil, grease and lubricants, operator, khalasi etc. charges required to work)

2. Evaluation of the quotation will be done on the basis of the following formulae:-

Evaluation cost per hr. = $A \times 0.3 + B \times 0.7$

Where A= Rate during Idle period.

B= Rate during working period.

3. Conditions:- (i) Service provider should be registered firm and should have valid service & Goods tax registration and Pan Card. Attested copy of these should be submitted at the time of agreement.

(ii) Income tax, service and goods tax and royalty etc. as applicable will be deducted from the bill of service provider as per norms.

(iii) Maintenance and security of machine will be done by service provider.

4. In case of breakdown of machine, two times the rate of idle period will be deducted from the bill.

5. All the payment of the machine will be done on the entry in log book and daily attendance will be noted.
