संचिका संख्या-07/मु0-01-193/2025-1611/ यह आदेश माननीय उच्च न्यायालय, पटना द्वारा सी०डब्लू०जे०सी० सं०-3463/2025 भूषण कुमार राय एवं अन्य बनाम राज्य सरकार एवं अन्य में दिनांक-18.03.2025 को पारित आदेश के अनुपालन में निर्गत किया जा रहा है।

2. उक्त वर्णित वाद में माननीय उच्च न्यायालय, पटना द्वारा पारित आदेश का कार्यकारी अंश निम्नवत है:-


“... Per contra Mr. Arvind Ujjwal, learned Standing Counsel No. 4 appearing on behalf of the State informs that in the case of Mitendu & Ors. Vrs. The State of Bihar & Ors. (CWJC No.1894 of 2021), the co-ordinate Bench of this Court, vide order dated 28.02.2024, had observed that the case of the said petitioners are squarely covered by the order dated 01.02.2021 passed in CWJC no.7938 of 2020 (Manoj Kumar & Ors. Vrs. The State of Bihar & Ors.) and directed the Director, Primary Education, Bihar that he would pass a reasoned and speaking order in accordance with law within a period of four weeks, in case the petitioners file a detailed representation along with a copy of order dated 01.02.2021 passed in CWJC No.7938 of 2020.

3. Learned counsel further informs that in compliance of the order passed in the case of Mitendu & Ors. (Supra), the said petitioners have been granted benefit of pay scale of trained teachers with effect from the date of completion of their actual training and, notionally, they are treated to be trained teachers from the date they were entitled to be sent for training, in the light of the order passed in the case of Manoj Kumar & Ors. (Supra) ...”

3. उक्त पारित न्यायादेश के आलोक में विभागीय पत्रांक-1265 दिनांक-08.04.2026 एवं पत्रांक-1327 दिनांक-16.04.2026 द्वारा अद्योहस्ताक्षरी के समक्ष सुनवाई का मौका दिया गया। सुनवाई के क्रम में याचिकाकर्तागण द्वारा पक्ष रखा गया। जिसे विस्तार पूर्वक सुना गया।

4. सुनवाई के क्रम में वादीगण द्वारा अवगत कराया गया कि उनकी नियुक्ति वर्ष 2013, 2014 एवं 2015 में विभिन्न नियोजन ईकाई द्वारा अप्रशिक्षित शिक्षक के रूप में हुई। उक्त के उपरांत वे सत्र-2015-17 एवं 2016-18 में विभिन्न सरकारी प्रशिक्षण संस्थानों से D.El.Ed की डिग्री प्राप्त किये। वादीगण का दावा है कि उनका मामला सी०डब्लू०जे०सी० सं०-16165/2019, किशोर कुमार एवं अन्य बनाम राज्य सरकार एवं अन्य के वादीगण के समरूप है।

5. प्रस्तुत वाद के याचिका में अंकित किया गया है कि वादीगण को सत्र-2015-17 एवं सत्र-2016-18 में प्रशिक्षण हेतु भेजा गया था तथा प्रशिक्षण पूर्ण होने के उपरांत उन्हें अपने मूल विद्यालय/नियोजन इकाई/प्रखण्ड शिक्षा पदाधिकारी, कार्यालय में योगदान देने हेतु विरमित किया गया है। उक्त दोनो सत्रों की परीक्षा एक ही बार आयोजित की गई, जिसके परीक्षाफल का प्रकाशन दिनांक-19.01.2019 को किया गया। सी०डब्लू०जे०सी०

सं-3463/2025 के वादी संख्या-13 (श्रीमती रीचा कुमारी) को छोड़कर अन्य सभी वादीगण ने प्रथम प्रयास में ही उक्त परीक्षा में उत्तीर्णता हासिल किया।

6. अंकनीय है कि प्रस्तुत वाद के वादीगण का नियोजन बिहार पंचायत प्रारंभिक शिक्षक (नियोजन एवं सेवाशर्त) नियमावली, 2012 के तहत अप्रशिक्षित शिक्षक के पद पर नियोजन इकाई द्वारा किया गया है एवं वादीगण को सेवाकालीन प्रशिक्षण की सुविधा विभाग द्वारा उपलब्ध कराया गया। उक्त मामले में विभागीय आदेश ज्ञापांक-547 दिनांक-22.06.2020 द्वारा सी०डब्लू०जे०सी० सं०-16165/2019 (किशोर कुमार) एवं विभागीय आदेश ज्ञापांक-2132 दिनांक-02.12.2024 द्वारा सी०डब्लू०जे०सी० सं०-1894/2021 (मितेन्दु) में संबंधित वादीगण को प्रशिक्षणचर्या पूर्णता की तिथि से प्रशिक्षित शिक्षक का वेतनमान वैचारिक (Notionally) रूप से तथा परीक्षाफल प्रकाशन की तिथि से वित्तीय लाभ दिये जाने का निर्णय लिया गया था।

7. उक्त मामला के समरूप एक अन्य वाद सी०डब्लू०जे०सी० सं०-7938/2020 मनोज कुमार एवं अन्य में माननीय न्यायालय द्वारा दिनांक-01.02.2021 को न्यायादेश पारित किया गया, जिसका कार्यकारी अंश निम्नवत् है:-

**“...The respondents are directed to ensure that the petitioners are paid pay scale/grade pay which they are entitled to from the date of completion of training i.e. May, 2017. The arrears of salary shall be calculated accordingly and paid to them within a period of three months from the date of receipt/production of a copy of this order...”**

उपरोक्त पारित आदेश कि विरुद्ध विभाग द्वारा LPA No.-456/2021 दायर किया गया, जिसमें माननीय उच्च न्यायालय, पटना द्वारा दिनांक-03.04.2025 को न्यायादेश पारित करते हुए सी०डब्लू०जे०सी० सं०-16165/2019 (किशोर कुमार) में निर्गत विभागीय आदेश ज्ञापांक-547 दिनांक-22.06.2020 द्वारा प्रशिक्षणचर्या पूर्णता की तिथि से प्रशिक्षित शिक्षक का वेतनमान वैचारिक (Notionally) रूप से तथा परीक्षाफल प्रकाशन की तिथि से वित्तीय लाभ दिये जाने के निर्णय को नकारते हुए उक्त अपील को खारिज कर दिया। उक्त आदेश का कार्यकारी अंश निम्नवत् है:-

**“...In this backdrop, appellants cannot take decision of notional benefits when the order is very specific to the extent that necessary decision in this regard with all consequential monetary benefit must be taken by the director. The same decision has been passed in number of cases including the present case. The appellants has taken their own time to publish the result with reference completion of training course in the month of May, 2017. For no fault on the part of the respondents, denial of certain service and monetary benefit on behalf of the appelants would be arbitrary, therefore, the appellants have not made out a case so as to interfere with the impugned order of the learned Single dated 01.02.2021 passed in CWJC No 7938 of 2020...”**

उपरोक्त पारित आदेश के विरुद्ध विभाग द्वारा माननीय सर्वोच्च न्यायालय, नई दिल्ली में SLP (Civil) Diary No(S).-66035/2025 दायर किया गया। उपरोक्त वाद में माननीय सर्वोच्च न्यायालय द्वारा दिनांक-15.01.2026 को न्यायादेश पारित कर माननीय उच्च न्यायालय, पटना द्वारा LPA No.-456/2021 में दिनांक-03.04.2025 को पारित न्यायादेश को यथावत रखते हुए उक्त SLP को खारिज कर दिया गया।






8. उपरोक्त न्याय निर्णय के परिप्रेक्ष्य में सी०डब्लू०जे०सी० सं०-25063/2019, रंजीत कुमार एवं अन्य में माननीय न्यायालय द्वारा दिनांक-13.12.2019 को पारित न्यायादेश का अनुपालन करते हुए विभागीय आदेश ज्ञापांक-972 दिनांक-09.03.2026 निर्गत किया गया है।

9. सी०डब्लू०जे०सी० सं०-2080/2026 के वादीगण के D.El.Ed के अंकपत्र का परिशीलन किया गया जिसमें पाया गया कि वादी संख्या-13 (श्रीमती रीचा कुमारी) को छोड़कर अन्य सभी वादीगण ने प्रथम प्रयास में ही उक्त परीक्षा में दिनांक-19.01.2019 को उत्तीर्णता हासिल किया है परन्तु रीचा कुमारी पूरक परीक्षा के माध्यम से दिनांक-28.03.2019 को उत्तीर्ण हुई।

10. उपरोक्त वर्णित परिप्रेक्ष्य के आलोक में संबंधित जिला शिक्षा पदाधिकारी को निदेश दिया जाता है कि विभागीय आदेश ज्ञापांक-972 दिनांक-09.03.2026 के आलोक में वादी संख्या-13 (श्रीमती रीचा कुमारी) को छोड़कर अन्य सभी वादीगण को प्रशिक्षणचर्या पूर्णता की तिथि से प्रशिक्षित शिक्षक के वेतनमान का वित्तीय लाभ देते हुए अंतर वेतन का भुगतान सुनिश्चित करेंगे। साथ ही इससे इत्तर यदि कोई मामला हो तो उसे अधोहस्ताक्षरी के संज्ञान में लाकर ही उस पर निर्णय लिया जाय।

अतएव उक्त अभिमत के साथ प्रस्तुत मामले को निस्तारित किया जाता है।
