Sealed Quotation is invited from the service provider for the procurement of working and well maintained 1 No 5 KVA Generator on hire basis for the flood period to be deployed at places under jurisdiction of Eastern Embankment Division, Supaul. As per requirement, the machine may be moved/deployed at any vulnerable point under the jurisdiction of this division. The required Generator will be used in flood fighting work at site in night (8 hours) whenever & wherever required. Therefore the service provider will have to be ready all the time at site with all required as follows:-

**1. Specification of Generator.**

- I. 5 KVA Generator.
- II. Flood light/LED light 50 watt 3, Nos.20 watt 6 Nos. & 9 watt 12 Nos. to cover the whole length of site
- III. Generator Operator 01 No.
- IV. P.O.L

**2. Evaluation of the quotation**

(Rate should be inclusive of machine operator, Fuel and all other types of P.O.L required for the working of machine, etc. charges & including all taxes).

Work will be allotted to the service provider whose evaluation cost will be lowest, subjected to final approval of competent authority

- (i) Sealed quotation is being hereby invited by agencies which will apply for nomination under C.E, Flood Control & Drainage, WRD, Birpur. For F.F.Work-2026
- (ii) Service Providers should be of valid registration from RCD (for Class IV) & WRD and should have valid G.S.T registration, character and PAN Card. Attested copy will have to be submitted at the time of filling nomination.
- (iii) Income Tax, service Tax etc. as applicable will be deducted from the bill of service provider as per Norms.
- (iv) Maintenance and security of machine will be done by service provider.
- (v) Attested Copies of all essential documents related to Generator will have to be submitted at the time of Deployment.
- (vi) In Case Generator is taken on lease by the service provider, the affidavit for the same of lender's must be attached in original with the quotation.
- (vii) Payment will be done on the basis of approved nomination as well as Format-24 and as per availability of allotment. No Claim whatsoever will be entertained for this.
- (viii) Generator will have to be made available in ready to working condition with P.O.L.& operator for night shift on site
- (ix) All Valid documents would be submitted with quotation.
