



TERMS & CONDITION :-

1. (a). It is mandatory that Bid processing fee and cost of B.O.Q for Quotation (Nonrefundable) must be paid through Online mode (e-Payment mode) / Internet Payment Gateway (Credit/Debit card), Net Banking, NEFT/RTGS in e-Quotation/ e-Procurement system.
(b). In e-Quotation/ e-Procurement system, the amount required to be deposited as Earnest Money for this Quotation, can be paid either through Internet Payment Gateway (Credit / Debit card), Net Banking, NEFT / RTGS or Physical Mode / Manual Payment System. Earnest Money can be paid through Internet Payment Gateway (Credit/Debit Card), Net Banking, NEFT/RTGS in online mode.
In case of Physical mode / Manual Payment system the Earnest Money Deposit should be in the shape of unconditional Bank guarantee issued from any schedule bank/ Nationalized bank within state in favor of Executive Engineer (Mechanical), Irrigation Mechanical Division, Birpur and valid till (120 days + 45 days = 165 days) (as per the format in SBD) If issued from any bank situated outside the state of Bihar, then it will have to be issued from a bank situated within the state of Bihar before executing the work agreement.
(c). "Bids along with necessary online payments must be submitted through e-Procurement portal www.eproc2.bihar.gov.in before the date and time specified in the N.I.Q. The department doesn't take any responsibility for the delay/non submission of Quotation /Non-Reconciliation of online Payment caused due to non-availability of internet connection, Network Traffic/Holidays or any other reason".
(d). "BSEDC Processing Fee and Quotation Fee/BOQ Fee has to be paid through e-Payment mode only. EMD may be paid either through online or offline mode".
(e). Departmental letter number 385 dt.26.08.2020. and memo issued by department of information technology, Government of Bihar letter Number 752 dt. 21.08.2020 will be implemented in full.
2. Any Quotationer registered with the Central Government/ Water Resources Department, Govt. of Bihar/any Firm /Corporation having registration Certificate may participate in the Quotation.
3. While participating in e-Quotation process, the Quotationer shall have to get themselves registered to get user ID, Password and digital signature. This will enable them to access the website www.eproc2.bihar.gov.in and download/participate in e-Quotation process.
4. E-Quotation documents can be downloaded from and dully filled document can be uploaded only on website: www.eproc2.bihar.gov.in.
5. Quotationers/Quotationer can access Quotation documents on the above-mentioned website, fill them and submit the completed Quotation documents as Electronic Quotation on the www.eproc2.bihar.gov.in itself only. Bidder/Quotationer shall attach Scanned copies of all paper with "Page Numbers" (no document to be repeated), i.e. Earnest Money & the certificates required in Eligibility criteria.
6. Corrigendum /Addendum/Corrections, if any will be published on the website only. The undersigned reserves the right to cancel/extend the bid without any prior information or assigning any reason.
7. The bidders should list up serial No. of scanned documents before uploading, so that the particular document may be located soon on the basis of Serial No/Page No. All documents must be uploaded on PDF, MS Office (Compatibility Mode), JPEG, ZIP format. Claims will not be entertained if uploaded documents were not able to download/open the other format.
8. The Quotationers should fully satisfy themselves of Download ability/Visibility of scanned uploaded documents.
9. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last minute technical snags.
10. Conditional Quotation will be rejected.
11. Estimated cost and quantities of the work can vary. Earnest Money Deposit and Cost of BOQ will change accordingly.
12. Submission of Affidavit for this specific work, issued in between the date of NIQ and last date for uploading is mandatory:-
 - (a) "I, the undersigned, do hereby certify that all the statements made in the required attachments are true and correct, and if found fake/forged, the undersigned will be liable for infliction upon the F.I.R and lawful punishments as well as black listing'.
 - (b) The undersigned also hereby certifies that neither our firm M/s ----- has been blacklisted nor has abandoned any work in any Government department, India nor any contract awarded to us for such works have been rescinded, during last one year prior to the date of this quotation.

13. Quotationers must be satisfied himself with the site condition by visiting the site before uploading the Quotation. After uploading Quotation, no claim will be entertained for the same.
14. In case of more than one successful Quotationers having same minimum quoted rate, successful Quotationer will be decided by lottery system as per guide line of Bihar PWD code-163
15. The submission of rates under this quotation would not lead to guarantee for award of work.
16. Quotation are invited for Supply of only SKF Bearing of designated no.
17. Quotationer should submit rates inclusive of GST, Labour Cess etc. & other applicable taxes with Supply of material at site (Koshi Barrage, Birpur Nepal), i.e. transportation, packing/loading and unloading at the destination etc.
18. Quotation are accepted from registered firm/manufacturer/authorized Distributor/Dealer.
19. Quotationer should submit the Udyog Aadhaar or Udyam/S.S.I Registration for similar nature of work in the Ministry of Micro, Small and Medium Enterprises and it will be mandatory to attach the certificate of registration for the same, GST registration, PAN No. & Income tax clearness certificate at the time of submitting Quotation.
20. Deduction from the Quotationer Bill as Directed/Notified by the Department that is Income Tax @2% (Two Percent), GST 2% (Two Percent) etc as per rule and amount of welfare cess for Building and Karmkar Kalyan Board@ 1% (One Percent) shall be made.
21. Payment will be done after available Allotment.
22. Quotationer have to submit Guarantee Card of Materials for 15 (Fifteen) Months from Date of Supply or 12 (Twelve) Months from the Date of Installation, whichever is earlier and which have become unusable because of defects in materials.
23. The material must be insured and insurance charge will be paid by the registered Firm/Manufacturer/Authorized Distributor.
24. Delivery of materials within 01 (One) Month.
25. Full payment against actual delivery of materials with proper verification by consignee or his authorized officer after Test Report from SKF India Limited.
