LED Flood/Vapour light which may be increased as per requirement) at different locations on P.P. Embankment from km 0.00 to km. 28.00 including TRL-4 of Gandak River in West Champaran, Bihar under flood control division-2, Padrauna.  - ii. Only those Quotationers may participate who are nominated by Chief Engineer, Flood Control and Drainage, Water Resources Department, Gopalganj.
 - iii. Undersigned authority may not bound to allot the work to the Quotationer.
 - iv. Quotationer should have valid G.S.T. registration, Character Certificate and PAN card.
 - v. All taxes will be deducted from bill of Quotationer as per norms.
 - vi. Maintenance and security of Generator will be done by Quotationer.
 - vii. Rate quoted should be inclusive of all prevailing taxes and contractor profit etc.

6. Additional information may be obtained from the office Executive Engineer, Flood Control Division-2, Padrauna or from the office of Superintending Engineer, Flood Control Circle, Padrauna on any working day between 10:00 AM to 05:00 PM.
7. Running time of generator will be recorded in log book and payment shall be made on the basis of log book.
8. In case of breakdown of generator, two times the rate of generator with all setup, would be deducted from the bill.
