13. Any international/National level Bidder Registered in Central/ State Govt./PSU sector can participate in bid subjected to the conditions i.e., Registration in WRD, GOB before agreement must require after issuance of LOA
14. (a) Under e-tendering/e- Procurement system, Bid processing Fee and Cost of Document (that is non-refundable) to be paid through online mode i.e. Internet payment gateway (Credit/Debit card), Net banking, NEFT/RTGS only.  
(b) The amount deposited as Earnest Money Deposit under e-Tendering/Procurement system will be accepted in online mode (e-Payment mode). If Physical EMD is necessarily deposited by Tenderer then only Bank Guaranty are accepted. WRD, letter no. 385 dated 26-08-2020  
In Online mode, Earnest Money to be paid through Internet Payment Gateway (Credit/Debit Card), Net Banking, NEFT/RTGS.  
If Physical EMD is necessarily deposited by Tenderer then only unconditional Bank Guaranty are accepted and which is valid up to Validity of Bid (120 days + 45days = 165 Days). Bank guarantee issued from any schedule bank / Nationalized bank within state and valid up to bid validity period in favour of **Executive Engineer, Head Works Division, Birpur**. If Bank Guaranty issued from any bank situated outside the state of Bihar, then it will have to be issued from a bank situated within the state of Bihar before executing the work agreement.  
The original copy of the bank guarantee is to be made under the order issued by the Bihar Government Water Resources Department, Bihar Patna, letter no. 1/PMC/Vividh/879/2012-Part-II-88 Dated 29-01-2024. (All documents related to the tender will be accepted through online only. It will not be necessary to submit hard copies of any documents to participate in the tender. Earnest Money will be accepted through online payment or bank guarantee. It will be mandatory for the successful bidder to submit the necessary documents like all the affidavits in original and the Bank Guaranty in original before agreement)  
(c) "Bids along with necessary online payments must be submitted through e-Procurement portal [www.eproc2.bihar.gov.in](http://www.eproc2.bihar.gov.in), before the date and time specified in the NIQ. The department doesn't take any responsibility for the delay/Non-submission of Tender/Non-Reconciliation of online Payment caused due to Non-availability of internet connection, Network Traffic/Holidays or any other reason"  
(d) "BSEDC Processing Fee and Tender Fee/BOQ Fee has to be paid through e-Payment mode only. EMD may be paid either through online or Bank Guarantee."
15. Bidders/Contractor can access BOQ/tender documents on the above mentioned website, fill them and submit the completed tender documents as Electronic Tender on the website itself only. Bidders/ Contractor shall attach scanned copies of all paper, i.e. all important document & all certificates as required in Eligibility criteria.
16. Corrigendum/ Addendum/Corrections, if any will be published on the website only. The undersigned reserve the right to cancel/extend the bid without any prior information or assigning any reason.
17. The bidders should list up serial No/Page No. of scanned documents of each page before uploading, so that the particular document may be located soon on the basis of Serial No/Page No. All documents must be uploaded on PDF, MS Office (Compatibility Mode), JPEG, ZIP format Claims will not be entertained if uploaded documents were not able to download/open the other format.
18. The bidder should be fully satisfied themselves of Download ability/Visibility of scanned uploaded documents.
19. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last minute technical snags.
20. As per departmental letter no-988 dt-28.10.2009 the amount of welfare cess for Bhawan & Shramik Karmkar Kalyan Board @ 1% (one percent) will be deducted from the bill of the Contractor.

23. Estimated/BOQ cost and quantities may increase or decrease. Earnest Money Deposit will change accordingly.
24. Conditional Tender will not be accepted.
25. In case of more than one successful bidder having same minimum quoted rate, successful bidder will be decided by Lottery system as per guide line of Bihar PWD code.
26. In relation to execution of tender/implementation of work, compliance of Road Construction Department's letter No. 3162 (S) dated 09.05.2016 and updated orders/circulars issued by the department from time to time will be binding.
27. The Technical Bid will be evaluated as per direction given Vide Letter No. 6158 Dated 09-07-2014, Letter no. 200 dated 14.03.2016 and letter No-274 dated-18.04.2016 of Water Resources Department, Government of Bihar.
28. It is mandatory for joint venture as provide for the tender of more than 10.00 crore the provision made in Lt no.-8131 (S) dt-24.07.2012 of RCD will be followed.
29. Tenderer must enclose their valid Address, E-mail ID and telephone or mobile number on a separate sheet.
30. This NIQ is a part of the tender document. It is a mandatory for qualified bidder to submit security deposit in specified period and to perform agreement after issuing work allot.
31. Bidders are advised to read all the terms and conditions mentioned in the bid document.
32. Bidders must be satisfied themselves with the site condition by visiting the site before uploading the tender. After uploading tender, no claim will be entertained for the same.
33. Royalty Fee will be deducted on the basis of actual work done quantity.( if any applicable)
34. In the light of the Letter No. 152 dated 15.02.2024 of the Water Resources Department, the Chartered Accountant's audit report to be enclosed. Any other document prepared by a Chartered Accountant must have an **Unique Document Identification Number.(UDIN)** it will be different for each document. The details of each document can be checked from the website of the Institute of Chartered Accountants of India.
35. As per RCD, Patna Letter No. 4439(E) Dated-17.07.2023 & Departmental Letter No. 536 dated 18.07.2023 Order passed by the hon'ble High Court, Patna in C.W.J.C. No. 9941/2022 Dated-06.07.2023 shall be complied regarding rate quote.
36. Provision made in Department letter no-124 Dated 04.02.2021 is mandatory regarding character certificate.

37. **Technical Qualification & Documents to be submitted in technical bid envelope :-**

- (i) Original affidavit regarding correctness of information furnished with the bid document and submission of affidavit issued between Date of issue of the tender and date of uploading the tender will be mandatory.

**"I, the undersigned do hereby certify that all the statements made in the required attachment are true and correct and if found fake/forged, the undersigned will be liable for infliction upon the FIR and lawful punishment as well as black listing".**

Those Papers / Documents are valid which is issued before the receipt of tender and uploaded with tender documents for the process for clarification/ Modification. as per the section of 5.2 of R.C.D letter No-6158 Dt-09.07.2014. It means the tender will be decided on the basis of uploaded documents.

- (ii) The bidder must possess and submit work experience certificates along with the tender, demonstrating the **purchase of at least 40% of the total types of the equipments** required for this specific nature of work, as well as experience in their **operation and training**.

- (iii) The agency should have valid registration with appropriate statutory authorities as required under law. Copies of all such registrations such as PAN, GST etc. be Submitted.
- (iv) The bidder shall have ISO 9001:2015 certification/MSME Registration.
- (v) Before submitting the tender, the tenderers are required to read carefully the technical specifications, terms and conditions, specification of laboratory equipment to be supplied, maintenance policy and attach the quality report issued by the certified laboratory.
- (vi) The bidder/contractor will complete and upload the electronic bid form on the website only after receiving the bill of quantities from the website. All other important documents/earnest money amount/certificates required for the bid must be scanned and attached to the e-tender.
- (vii) The Bidder should have direct authorization from the Original Equipment Manufacturer (OEM) for SITC and supporting the equipment offered. Mandatory to submit Case Specific MAF & Technical Compliance from OEMs against those items (as specified in the technical specification sheet), must have NABL (in house/specialized third party facility) lab from past 3 Years, failing which offer will summarily be rejected.
- (viii) The bidder should submit schedules of installation and running of equipments as required for the technical specifications. A detail description of equipments/instruments with, essential technical and performance characteristics.
- (ix) Regarding Work Experience of Similar Nature of Work as mentioned in the tender document or NIQ.
