Sealed Quotation is Invited from Service Provider for the procurement of working and well-conditioned (02) two no, mobile ambulance (Tractor) on the hire charge basis for the period from date of Agreement to end date of flood period 2026 (Which may be extended) for where ever required under jurisdiction of Flood Control & Drainage Division, Biharsharif The mobile ambulance will be used in flood fighting works during day or night whenever and wherever required in urgency as per direction of E/I. The Service Provider will have to be ready all the time at site with driver, khalasi, unskilled labour, fuel etc.

(1) The mobile ambulance will consist of portable generator of 5 KVA capacity, Sand & Aggregate, 4 Nos halogen light, & 6 Nos folding chairs & 10 Nos of unskilled labour (will be provided by service provider) & Empty Cement bags, Nylon crates, empty geo bag & local sand filled Cement bags etc. (will be provided by Dept).

(2) Service provider should quote the rate for the following two conditions.

(i) In Idle condition Rate R ..... per hour. (Rate should be inclusive of all operational and maintenance cost e.g. operator, Khalasi etc charges with all taxes.)

(ii) During working period rate Rs..... Per hour (Rate should be Inclusive of all operational and maintenance cost e.g. fuel, mobil, grease, lubricants, operator, khalasi etc. charges required to work with all taxes.)

Note- (1) Idle working period = (12 hours - actual working hour) or idle hour maximum limited to 12hr/day (day= 24 hr.)

(2) Working period will be as per actual working hour/day and night.

(3) Evolution of the quotation will be done on the basic of following formula: -  
Evolution cost per hour  $(Ax0.3+ Bx0.7)$

Where A=Rate during Idle period B=Rate during working period

(4) Condition:-

Service Provider should be registered firm and should have valid GST registration. Character certificate and PAN Card. Attested copy of these should be submitted at the time of quotation. Taxes /Royalty etc. as applicative will be deducted from the bill of Service Provider as per Rules. Attested Copy of owner book of Machine will be submitted with quotation. In case of non-ownership, lease agreement with machine owner on stamp of Rs.- one hundred should be submitted with quotation.



- Maintenance and Security of Machine will be done by Service Provider.
- In case of breakdown of machine, two times the rate of idle period will be deducted from the bill.
- All the payment of the machine will be done on the basis of entry in Log Book and daily counting of machine and labours by concerned departmental officer. Any claim of contractor regarding entry of log book or counting will not be entertained.
- The Idle & Working hours counted together per day will be 12 hour, if working period comes out to be 12 hours or less. In case working hour more than 12 hour, payment would be made for that period on actual working basis and that case idle period would be nil.
